- 2. In this privacy policy, unless the context requires a different interpretation:
  - a. the singular includes the plural and vice versa;
  - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
  - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
  - d. "including" is understood to mean "including without limitation";
  - e. reference to any statutory provision includes any modification or amendment of it;
  - f. the headings and sub-headings do not form part of this privacy policy.

## Scope of this privacy policy

- 3. This privacy policy applies only to the actions of Manticore Security Ltd and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, Manticore Security Ltd is the "data controller". This means that Manticore Security Ltd determines the purposes for which, and the manner in which, your Data is processed.

## Data that is given to us by you

- 7. Manticore Security Ltd will collect your Data in a number of ways, for example:
  - **a.** when you contact us through the Website, by telephone, post, e-mail or through any other means;
  - **b.** When users complete contact and application forms;

in each case, in accordance with this privacy policy.

# Data that is collected automatically

- 8. To the extent that you access the Website, we will collect your Data automatically, for example:
  - **a.** we automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.

  - b. third party service providers who provide services to us which require the processing of personal data to complete relevant screening and vetting in accordance with BS7878 code of practice and to book employees onto shifts with third party companies as a subcontractor;
  - c. relevant authorities to complete relevant screening and vetting in accordance with BS7878 code of practice;
  - d. Credit reference agencies To complete relevant screening and vetting in accordance with BS7878 code of practice..

in each case, in accordance with this privacy policy.

### **Keeping Data secure**

- 12. We will use technical and organisational measures to safeguard your Data, for example:
  - a. access to your account is controlled by a password and a user name that is unique to you.
  - b. we store your Data on secure servers.
  - c. payment details are encrypted using SSL technology (typically you will see a lock icon or green address bar (or both) in your browser when we use this technology.

#### Data retention

### Your rights

- 17. You have the following rights in relation to your Data:

If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive."
